Please note:

- You must notify the Fernhurst Society Treasurer treasurer@fernhurstsociety.org.uk if you wish to cancel this Gift Aid Declaration, change your name or home address or no longer pay sufficient Income or Capital Gains Tax to cover your gift aid donation.
- If you pay UK Income Tax at the 'higher' or 'additional' rate and want to receive the additional tax relief due to you, make sure you keep a record of all your Gift Aid donations and include them on your Self-Assessment tax return or ask HMRC to adjust your Tax Code.
- If you pay less Income Tax and/or Capital Gains Tax than the Gift Aid claimed on your donations, it is your responsibility to pay the difference.
